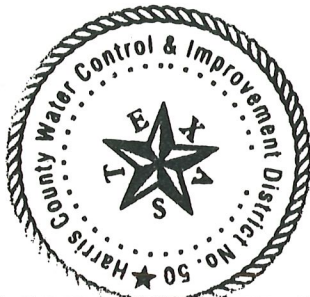


The meeting will be held at **7:00 p.m. on Wednesday, March 7, 2018.**


